Year Heads and the Senior Leadership Team noticed a worrying spike in negative incidents involving student interactions on social media and messaging apps before the mid-term break. I would urge you to continue to support your son/daughter's use of social media and messaging apps to help them to manage their interactions with peers in a way that avoids conflict and upset whether intended or otherwise. Our Facebook and Twitter pages regularly publicise events and resources to assist parents and students in working together to ensure that these platforms and apps are the source of positive communication.

The school's Cyberbullying Policy is available on our website along with our Anti-Bullying policy and it is essential for parents and students to be familiar with these for the wellbeing, happiness and protection of all.

Zeeko Education will be working with 2nd year students and their parents in December 2021 in order to address this need. 1st and 3rd year students and their parents will take part in these workshops early in 2022.

First Year Progress/ Information Evening 2021

The annual First Year Information evening will return this term on 11 November. Deputy Principal Ms Molamphy and Year Head Ms Morrissey will be in contact with parents of 1st years with details of the Zoom meeting for this event.

Covid 19 Update

Following the Cabinet decisions on the reopening of society on 22nd October there was no change notified regarding lifting of mitigation measures for schools. The guidelines on social distancing, hand hygiene, mask wearing, and respiratory etiquette therefore continue to apply and this is expected to continue in the medium to long term.

Our representative body, the ACCS, have informed schools that they will continue to engage with the Department seeking guidance and clarification for schools at the earliest opportunity. The Department of Education has committed to issue guidance during the week following midterm break on issues such as Parent Teacher Meetings, Physical Distancing, School Trips and a range of other school activities. We will continue to provide updates as soon as these are available.

A number of students are regularly losing or forgetting their facial coverings. The office staff and I would be grateful if you could check or remind your son/daughter to carry a spare covering with them to school each day.

Extra Curricular Activities

We have recently been able to safely resume a number of activities in the sporting and practical subject areas. My thanks go to all staff and students who have worked so hard to ensure that these vital activities can take place in a safe way in compliance with the relevant Public Health guidelines.

I wish both our students and volunteer teachers a successful and enjoyable year ahead!

Lockers

While there has been 'no change' to the Public Health guidance for schools, we do intend to begin to make lockers available to some students on a very limited basis that should enable us to continue to comply with the requirement to maintain distance and reduce interaction between students. We will for now focus on providing lockers for 1st year students who are unable to go home at lunchtime to leave/ collect books and whose schoolbags are therefore heavier than their classmates'. We will begin working on this immediately following the midterm break.

Canteen

Mr Clarke and the Senior Leadership Team have been investigating several different potential providers of canteen services so that we can in the coming weeks once more offer lunch options to staff and students on site. All providers are now experienced in providing school canteen service in a Covid-19 compliant way. We will have further news on this very shortly.

Careers Assessments & Standardised Testing

During the first half-term we were able to complete DATS testing with our Transition Year students and Cognitive Ability Testing (CAT4) with our 1st year students. These assessments will help us to support your son/daughter during their time in school.

Appearance Policy

We thank students and parents for the greatly improved standards of school uniform during the first half-term, particularly in the wearing of the school jacket. This is the only coat/ jacket that may be worn in school. This includes P.E. days when the school jacket should be worn over sports clothing. While the requirement for increased ventilation remains in place, students are permitted to wear their uniform jacket as needed for warmth. Non-uniform coats/ jackets however will continue to be confiscated in line with our regulations.

We remind students that runners/ trainers are not part of the school uniform and therefore should not be worn to school unless for practical P.E. classes. This is especially important now that the weather will become increasingly wet and cold. Plain black leather/ leather look shoes should be worn on non-PE days. The vast majority of students are cooperating with this and we appreciate that.

The Deputy Principals and I will continue to keep you updated as the term progresses and hopefully we will be able to move towards resumption of further aspects of PCS life during this academic year. Please remember that the subject teachers, tutor, SEN team, Guidance Team, Chaplain and Year Heads are all keen to work with you to support your son/daughter on a daily basis.
