Use of school premises by external organisations	Harm due to lack of safeguarding procedures	Medium	Visitor sign-in/out system; wearing of lanyards; supervision of use
Participation in external work experience or placements	Harm or exploitation in external placements	Medium	Work experience vetting and parental consent procedures
Student teacher placements	Inappropriate conduct or unsupervised access to students	Medium	Code of conduct for trainees; staff mentorship
Use of ICT, mobile phones, and photography	Circulation of harmful or inappropriate content	High	Mobile phone/ICT use policies; consent for photos
