

# Accessibility Statement for Portmarnock Community School

Portmarnock Community School is committed to ensuring digital accessibility for all users, including people with disabilities. We aim to provide a website that is perceivable, operable, understandable, and robust, in line with recognised accessibility standards and best practice.

This accessibility statement applies to the Portmarnock Community School website.

## Conformance status

This website is **partially compliant with the Web Content Accessibility Guidelines (WCAG) 2.1 Level AA**, due to the non-accessible content outlined below.

WCAG 2.1 Level AA is the accessibility standard required under the **European Union (Accessibility of Websites and Mobile Applications of Public Sector Bodies) Regulations 2020**.

## Preparation of this accessibility statement

This statement was prepared on **12/1/2026**.

The accessibility of this website was evaluated through a **manual, evidence-based auditing and remediation process**, supported by recognised accessibility testing tools and assistive technologies.

---

## How accessibility was tested

Accessibility testing was carried out using a **page-by-page review and remediation approach**, rather than a single automated scan.

Testing included:

- **Manual page-level accessibility audits**
  - Key pages were individually audited using **axe DevTools** and **Lighthouse** as diagnostic tools.
  - Issues were addressed iteratively on each page until **no serious or critical accessibility issues remained**.

- This process resulted in a measurable improvement in accessibility scores, moving from approximately **67% to 100% clean results** in both tools on 257 pages.
- **Manual functional testing**
  - Keyboard-only navigation testing to ensure all interactive elements are operable without a mouse.
  - Screen reader testing using **NVDA** to verify reading order, landmark structure, accessible names, and meaningful link text.
- **Visual testing**
  - Colour contrast testing to confirm that text and interface elements meet **WCAG 2.1 Level AA contrast requirements**.

Automated tools were used to identify potential issues, but all remediation decisions, verification, and validation were carried out manually to ensure real-world accessibility rather than tool-only compliance.

---

## Accessibility remediation approach

Accessibility improvements were implemented through an **iterative remediation process**, involving repeated testing, adjustment, and re-testing of individual pages and templates.

Particular attention was given to:

- Navigation landmarks and ensuring unique, meaningful accessible names
- Discernible link text and link purpose
- ARIA labelling and role management where native markup could not be altered
- Assistive-technology compatibility in cases where third-party tooling imposed technical constraints

This approach ensured that accessibility fixes were applied consistently and verified in practice, not solely by automated reporting.

---

## Non-accessible content

Despite ongoing efforts to improve accessibility, some content may not be fully accessible for the following reasons:

- Certain layout and structural elements are generated by third-party page-building tools and cannot be directly modified.
- Embedded third-party content (such as external calendar services) is outside the direct control of the school and may not fully conform to WCAG 2.1 Level AA.

- Some **older documents**, including PDF files published prior to the introduction of current accessibility standards, may not be fully accessible (for example, missing document structure, tags, or alternative text).

Where possible, newer documents are created with accessibility in mind, and alternative formats or assistance can be provided on request. Accessibility improvements will continue to be incorporated as part of ongoing site maintenance.
